DESCRIPTION OF COURSE: This course explores contemporary issues in art, education, and society influencing art education. Through weekly readings, discussions, and personal research projects students will examine and research contemporary issues and theoretical developments in art education. Topics covered in the course may include contemporary approaches to art curriculum planning, multiculturalism, art assessment practices, postmodern theory, school-community partnerships, censorship issues, technology, standardized testing, art education advocacy, creativity, and more.

PURPOSE AND OBJECTIVES OF THE COURSE: This course is designed to explore contemporary events, theories, trends, and practices that impact the field of art education. Together, we will explore a series of contemporary issues and practices in art education and locate the field within broader cultural context. Individually, students will develop personal positions and identify areas for further research and critical engagement within art education. At the completion of this course, graduate art education students will be able to:

- discuss internal and external influences upon the field of art education;
- demonstrate an understanding of contemporary writings, movements and issues related to current practices in the field of art and art education;
- be acquainted with and use current journals and online resources relevant to art education;
- speculate about possible future directions in the field of art education;
- recognize contemporary issues in art education;
- situate a variety of issues in regard to personal interest and art and art education practices.

The primary instructional methods of this course include weekly assigned readings and online group discussions of course topics, presentations, small group work, online research, and project work. Extensive reading and personal research will be required to help students achieve the course objectives.

COURSE REQUIREMENTS: To achieve the objectives of the course, students will:

- Read, synthesize and respond in a critical refection on selected readings;
- Contribute to the course content through active engagement in online discussions and collaborations;
- Bring their voice and contribute to an issue in contemporary art education;
- Complete an independent research project extending the course content;
- Participate in the online learning community and the resources available;
- Develop skills to craft questions and investigate issues that are personally meaningful and significant the field of art education

METHODS OF INSTRUCTION: The primary instructional methods of this class include lectures and group discussions of assigned readings. Extensive outside research will be required to help students achieve the course objectives. Education is an ongoing process of self-reflective synthesis of course content, individual research, and future paths. You should take every opportunity to take advantage of this and extend the class in a direction that is most valuable to your unique needs in pursue and art educational career goals. E-Leaning (LMS- SAKAI) Internet-based systems will be used as an extension of this course. I use minimal paper and never collect assignment in class.

COURSE REQUIREMENTS: To achieve the objectives of the course, the student will:

- read and synthesize selected readings in art educational research
- construct an annotated bibliography on a subject of research in the field of art education,
- conduct a pilot-study based on a researchable question(s) of personal interest,
- complete a written proposal for an independent research project, and
- short presentation of semesters research proposal.

EVALUATION: Evaluation criteria used in each of these areas will be discussed in class. Final grades will be calculated according to the following criteria:

- ✓ Written reflection on readings. (7) (30%)
- ✓ Collaborative Project/critical commentary, a proposal title, blurb, and outline for a actual conference, or prepare a book review for a journal on a current issue related to YOUR teaching and research interests/passions (20%)
- ✓ Annotated Bibliography APA style (10-25 sourses)
- ✓ Class Participation/activities

✓ Independent research project/paper related to the course content (30%).

Evaluation criteria used in each of these areas will be provided for each graded activity. Incompletes will only be given to students who are in good standing, but because of unusual circumstances are unable to complete the course requirements in the allotted time. In order to earn an A in this class all assignments must be completed and on time. Your work should demonstrate an ongoing process of self-reflective synthesis and critical analysis of course topics including your individual research interests and evidence of transformative thinking and learning.

READING RESPONSE GUIDELINES:

- (a) a critical analysis of specific points in the reading(s), (what are the author's arguments)
- (b) what evidence supports the author's argument
- (c) reflections on the relation of the ideas in the readings to your life, teaching, research, and/or art.
- (d) place a question raised by the reading at the bottom.
